

Public offer to enter into a donation agreement

This public offer (the ‘Offer’) is a proposal by the Roscongress Foundation (the ‘Foundation’) to enter into a donation agreement with anyone who accepts the Offer in accordance with article 582 of the Civil Code of the Russian Federation (the ‘Agreement’) under the conditions outlined below.

This Offer is a public offer as defined in paragraph 2, article 437 of the Civil Code of the Russian Federation.

This Offer enters into effect the day after it has been published on the Foundation’s website located at the address: roscongress.org.

This Offer remains in force indefinitely. The Foundation reserves the right to rescind the Offer at any time without providing an explanation.

The Offer may be amended at any time, with any modifications or additions entering into effect the day after they have been published on the Foundation website.

Moscow, Russian Federation is considered the location of this Offer.

Essential conditions of this Agreement

In accordance with this agreement, the Donor makes a voluntary donation of their own monetary funds using any method included in the Payment Rules published on the website roscongress.org. The Foundation agrees to accept this donation and use it in accordance with its designated purpose.

Designated purpose of the donation: organising aid to elderly and limited-mobility citizens who find themselves in self-isolation and are considered at risk due to the spread of the COVID-19 coronavirus. This includes the provision and delivery of food, medicine, and essential goods to the aforementioned category of Russian citizens.

Donation amount: the donation amount is determined by the Donor.

By entering into this Agreement, the Donor does not establish a time limit within which the Donation must be used by the Foundation. The Donor has the right to request the cancellation of the donation and the return of the transferred monetary funds in compliance with the current legislation of the Russian Federation.

If any or all of the donated funds cannot be used for their designated purpose because the need has been satisfied or conditions have made their use impossible, these funds are not returned to the original Donor but are instead reallocated by the Foundation towards the Foundation’s statutory activities.

The Donor enters into the Agreement by accepting the Offer. This Offer is considered accepted when the Donor completes their money transfer using any of the payment methods indicated on the Payment Rules published on the website roscongress.org.

By accepting this Offer, the Donor indicates that they have read and agree to all of the conditions included in this Voluntary Donation Agreement with the Foundation.
